**Tuition Payment:** I understand that tuition for the entire school year is due before the beginning of the school year. I have the option of paying in monthly installments. If I choose to make monthly installments I will be making a total of 10 payments as follows: Before August 5, 2012 I will pay the yearly supply fee of \$150.00 and the first tuition installment of \$660.00. Thereafter I agree to make monthly installment payments of \$660.00 on or before the 5th of each month until I have paid the \$6600.00 tuition in full. My second payment is due September 5, 2012 and my tenth and final payment is due May 5, 2013. I understand that the school holidays are listed on the Montessori School calendar and that I am only paying for those days school is open. I agree to pay the full installment amount each month even though my child misses some days during a month, and regardless of the reason.

**Withdrawing Early:** Before the sixth(6) day of class, if I'm not completely satisfied with the school, I can ask for a refund of the first tuition payment and withdraw my child without giving notice.
